

# Front-End Estimation

Front-end estimation only uses the numbers in the very left column.

If you are working with a 2 digit number, you will round to the nearest tens place, and if you are working with a 3 digit number, you will round to the nearest hundreds place.

Examples:

$$\begin{array}{r} 64 \\ +22 \\ \hline \end{array} \rightarrow \begin{array}{r} 60 \\ +20 \\ \hline 80 \end{array}$$

$$\begin{array}{r} 578 \\ -241 \\ \hline \end{array} \rightarrow \begin{array}{r} 600 \\ -200 \\ \hline 400 \end{array}$$

$$\begin{array}{r} 55 \\ +31 \\ \hline \end{array} \rightarrow \begin{array}{r} 60 \\ +30 \\ \hline 90 \end{array}$$

$$\begin{array}{r} 67 \\ +11 \\ \hline \end{array} \rightarrow \begin{array}{r} 70 \\ +10 \\ \hline 80 \end{array}$$
